# CHAIRMAN'S REPORT

# THE 2019 SEASON FOR THE MACARTHUR FOOTBALL ASSOCIATION HAS BEEN AN EXTREMELY SUCCESSFUL AND REWARDING ONE ON AND OFF THE FIELD.

On the field, with just under 11,000 registered players, there were great and competitive games every weekend. We had three huge weekends of big Grand Finals as well as a very successful City vs Country dual on the long weekend in June. I would also like to congratulate and note some great achievements by some of our teams this season. The MFA have newly crowned Champions of Champions with the Narellan Rangers Under 17 Division 1 boys team winning the ultimate prize. On the representative front, we had our Macarthur Association Youth League under 14 team and the Camden Tigers under 14 NPL2 youth league team win their respective Football NSW Grand Finals.

Congratulations on a great season to all three teams. Off the field it has been an extremely busy year but one where The Board, Staff and Member Clubs have worked in collaboration to make important changes to strengthen the MFA moving forward. Among these was Constitutional reform and I would once again like to thank and acknowledge the appointed working group led by Salv and Rahul for all their time and effort on this as you all did a tremendous job. To have it passed unanimously was a great result and I thank you all for your input along the way. A full Competition review was undertaken for the first time by a professional external company initiated by Salv and the Board. In consultation with Life Members, Clubs and Members all provided us important feedback and direction for the upcoming 2020 season and beyond. With a big overhaul especially with Men's and Women's M-League and the introduction of an under 21's M League 'Colts' competition as well.





I would also like to thank our MFA media team. John, Jill and Amy who were out at grounds again each weekend covering the MiniRoos and junior games which continue to get great support on social media. In addition, we covered M-League and Women's M-League games this season, which we will continue to build on.

A big thanks to our Macarthur Referees who once again have done a great job and provided excellent coverage of games throughout the season. There were some notable individual award winners as well with one of our Referees, Chloe Gray, being awarded the FFA's National Female Referee of the Year award, which is a fantastic achievement. We also received two Football NSW awards with Tamara Robbins from Ingleburn Eagles receiving the prestigious Fair Play Award and Paul Ellis receiving a State Award for his contributions and service with the Camden Falcons. We congratulate Chloe, Tamara and Paul on their awards.

A big win for the MFA this year was securing Cunningham Park at Gregory Hills and we are looking forward to a New club, Gregory Hills FC, joining us for the 2020 season. We also thank Mayor Theresa Fideli and Camden Council for their support with this. I would also like to thank Campbelltown Council, Wollondilly Council and our State and Federal Members for all their continued support.

The MFA is also looking forward to supporting the region's new A-League team next season: Macarthur FC, the Bulls. This will transform the game in the Macarthur area and will create many opportunities for our players, giving young footballers the complete pathway from MiniRoos to Professional Football in Macarthur. It also gives us our own local team to support and enables us to stay local to watch A-League games in Campbelltown. We hope to see Bulls with a W-League team soon, as the girls' game is going to erupt in Macarthur.

I would like to thank all our Club Presidents and their Committees and Volunteers for all your time and effort in running your clubs. Our Players, Coaches, Managers, Families and Supporters for being part of the MFA. We also thank our great sponsors; Wests League Club, McDonalds, Marsdens Law Group, Guzman Y Gomez, Deploy and Stanno. I would also like to thank my fellow Board Directors and our LCC, JC, GPC and SPC Members for all your time and effort to the MFA. Thank you to our dedicated staff Michelle, Steve, Norm and Braydan, led by our General Manager Salv Carmusciano, who have initiated and implemented good policy and change to move us forward.

#### 6. GENERAL BUSINESS RELATED TO FINANCIAL AND AUDITORS REPORTS

NAR – Coaching expenses \$77,469. Wages and coaches expenses \$316,307. Daryl acknowledged Norm Boardman's wage. The addition to SAP is an extra \$14,000. Increase in ADP and coaching clinics.

NAR - Ground hire \$6,231 to \$19,034. Daryl Wray said due to SAP and hire of extra grounds. Extra training. NAR said the cost is excessive and quite high. The previous year MFA used Liquidamber at NAR's expense.

TIG – Is the ADP increase under the coaching clinic income? Daryl Wray said yes. Coaches were paid. Income doesn't marry up with expenditure. Daryl Wray said MFA is paying ADP coaches.

NAR - Equipment and Uniforms increase. Daryl Wray said SAP and extra SAP programs, equipment and clothing.

Darcy Lound said Norm Boardman put in for a licence for a SAP program.

BUR – Special purpose accounts. Director's financial dealings with the Association should be declared at the bottom of the accounts that states Daryl Wray's company is employed by the Board to run the Accounts. Daryl Wray said Bookkeeping is a separate line item.

Col Smith (Life Member) - Photography expense. Daryl Wray said around the grounds Association photography for social media over 15 weeks (included all clubs). Col Smith said it's a big promotion. Darcy Lound said it was a success. ESC said it's not expensive when you consider all facets.

NAR – Increased costs in coaching equipment. Did the income run to profit? Daryl Wray said as at 30 June there was a small profit. Runs past 30 June. Total figures for review and present to the Board. Additional programs self-funded as a minimum. Daryl Wray said the objective is to have development programs break even.

NAR - Physiotherapy fees. Daryl Wray said for SAP and Youth League. Players pay \$1,500 for the season so it's to help them get back on the field.

OPR - Are Bookkeeping fees increasing in 2019? Daryl Wray said not at this stage. Daryl Wray is a Board member doing the Bookkeeping. Daryl Wray said it's a line item. BUR said it should be a statement. OPR said the Board has to disclose if there are business links. Col Smith said it's a conflict of interest. OPR said it's a significant increase. Did the Board approve the pay rise? Daryl Wray said it was voted on by the Board. OPR said four teams in SAP doubled the work? Daryl Wray said there is a lot more work. OPR said every time he sees a financial report it creeps up. Daryl Wray said with the finances, there is a link to coaching and development now. That is where the amount increases.

Daryl Wray said financials are tabled at Local Clubs meetings. OPR said it was after the fact. OPR said it was \$12,000, now it's \$16,000. OPR said you must be 120 per cent transparent because Daryl Wray is a Board member. Legal advice was sought. OPR said Board members haven't voted on the approval of Daryl Wray's increase.

Darcy Lound said the Board will take the matter on notice and will respond to the clubs.

Rahul Lachman said the conflict was addressed and dealt with appropriately. Daryl Wray was not present at that meeting. OPR said they don't have access to Board Minutes. What does the Board do for 12 months? The Board needs to be transparent. Other Associations provide Board Minutes e.g. Nepean.

STM – Presentation Trophies and Expenses up \$10,262. Daryl Wray said due to SAP. There was an underestimation of medallions for Gala Day. purchased for two years.

Prizemoney \$19,000. Daryl Wray said due to M League. Up \$7,000 due to split. Daryl Wray said also for previous season. NAR said that contradicts the last meeting minutes. Last year (2017) \$14,000, report \$12,000. Numbers don't add up. Daryl Wray to check and advise. Daryl Wray said it could be a \$2,000 cheque that wasn't banked so is added elsewhere.

# GENERAL MANAGER'S REPORT

SERVING THE MACARTHUR FOOTBALL **ASSOCIATION OVER THE PAST YEAR** HAS BEEN AN INCREDIBLY REWARDING AND ENJOYABLE EXPERIENCE. OUR **GAME IS FORTUNATE TO HAVE SUCH** PASSIONATE, COMMITTED VOLUNTEERS POWERING EACH CLUB AND PROVIDING **OPPORTUNITIES FOR THE COMMUNITY TO** PARTICIPATE AND COMPETE. IT IS THANKS TO THESE MEMBERS THAT FOOTBALL IN MACARTHUR IS IN SUCH GREAT SHAPE.

From an administrative perspective, the focus of the Association was on the following objectives:

#### 1. DELIVERY OF A FULL COMPETITION DRAW BY 20 APRIL 2019

The MFA became the first Football Association in NSW to deliver a full draw. This is not an easy task, given the tight timeframes from the team nomination period to the start of the season. There are also several forced changes to the fixture due to factors out of our control, such as the State Cup and inclement weather. However, members invest significant time and money into a full season of football and understanding the full fixture as early as possible is important to assist our members plan their time appropriately. Therefore, we have a duty to deliver the fixture in a timely manner. To that end, I would like to acknowledge and thank the MFA Competitions Manager Steve Carroll for executing this ahead of schedule in 2019.

#### 2. UNDERTAKE AND COMPLETE A COMPREHENSIVE REVIEW OF **ALL COMPETITIONS**

The MFA commissioned sports consultancy agency Sports Business Partners to undertake an independent review of all MFA Competitions as part of our commitment to deliver optimal competition structures for the community. The process included a comprehensive consultation period with members of the Football Community, including Club Committee Members, Life Members, Players, Coaches and Referees. Whilst all competitions were reviewed, emphasis was placed on the M-League and The Women's Game as strategic imperatives. A Final Report was produced, with the MFA now looking to implement many of the recommendations.

#### 3. UNDERTAKE CONSTITUTIONAL **REFORM**

On Wednesday, 16 October 2019 Members of the Association passed by special resolution the adoption of a new Constitution and Regulations. The formulation of the new Constitution and Regulations involved a comprehensive consultation process which commenced in February. A Working Group was established representing the members to ensure the proposed Constitution was in line with modern, best practise governance and to best serve the interest of the game. I would like to thank and acknowledge all members of this Working Group: Steve Holzer (NAR), Colin Campbell (RUS), Russell King (TAH), Michael Tripodi (CUC), Michael Winter (ING), David Skillen (CAM), Peter Kovacsics (MFA), Richard Whicker (Life Member), Peter Ellington (COB), Steve Carroll (MFA), and Rahul Lachman (MFA Legal Counsel). I would also like to acknowledge the assistance of the Local Competitions Committee during this process. The adoption of a new Constitution and Regulations marks the start of a new era for the Association and its members.

#### 4. SECURE CUNNINGHAM PARK, **GREGORY HILLS**

In a competitive sporting landscape, the MFA was delighted to receive the keys to the new Cunningham Park in Gregory Hills. The additional facility provided some relief as our code surged passed 10,000 registered players in 2019. Cunningham Park hosted training sessions for MFA member clubs, as well as representative programs. M-League and State Cup fixtures were also played out of the venue. In 2020, the venue will be home to Macarthur's newest grassroots club: Gregory Hills FC.

### 5. LAUNCH A MULTI-YEAR STRATEGIC PLAN

The MFA will soon publish the 2020 - 2025 strategic plan for the game. Once again, the process of formulating the strategic plan consisted of a comprehensive consultative process which commenced twelve months ago. The plan reflects the game's main strategic agenda over the next five years, including the issues and opportunities ahead of us. We have much to be optimistic about in Macarthur and it is only if we unite as a code that we will truly reach our potential.

In addition to these objectives, the MFA went about restructuring the business, including a review and update of suppliers, policies and processes. To ensure we are resourced sufficiently to meet the growing needs of our members, the MFA welcomed Braydan Pidgeon to the newly created role of Administration Officer. We are excited to have Braydan join the team and service our members. A special thank you to the staff at the MFA for their efforts throughout the year.

The team is incredibly passionate about the game and are dedicated to delivering outstanding customer service and support to our members.

We would like to acknowledge the support of our long-term partners: Wests Campbelltown, McDonald's in Macarthur, Marsdens Law Group, and Stanno. This year we welcomed new partners Deploy Football as the match ball partner of the M-League Competition and Guzman Y Gomez as the official partner of our Junior Leagues. We thank our partners for their support of our great game.

On a personal note, I would like to thank all members of the MFA Board for affording me the opportunity to serve the game in Macarthur and for their staunch support and counsel they have offered over the year. They are a massive contributor to the standing MFA has in the broader football community.

# COMPETITION MANAGER'S REPORT

#### **SEASON 2019 WAS A GOOD YEAR FOR** FOOTBALL IN THE MACARTHUR DISTRICT.

For the first time ever, player numbers were in advance of 10,000, with growth experienced across MiniRoos, Seniors and Girls Football. The increase in player registrations resulted in significant growth in actual team numbers, with 835 teams taking the filed in 2019 – another milestone.

Other noteworthy milestones and achievements included:

- · 112 Competitions in total
- · An average of 351 matches being played per round
- · A total of 6,353 matches played over the season
- · Full season draw released prior to the commencement of the 2019 season
- · The restructured M-League competitions, as agreed following consultation between the Clubs, was a great success and resulted in great football being played each weekend. Congratulations must go the Gunners Soccer Club for an MFA first in winning both the Premiership and Championship in the Men's First and Reserves competitions. Further congratulations to the Camden Tigers Women's team after going through another undefeated season to claim the 2019 "double"
- · Playing all the M-League Grand Finals on the final Sunday of the season was a resounding success
- · Lynwood Stadium hosted many M-League (Men's and Women's) matches during the season and we hope to offer the same opportunities during the coming seasons
- · Lynwood Stadium also hosted the Division 2 Grand Finals for the first time
- · St Mary's Eagle Vale stepped in to host the Division 3 and below Grand Finals on behalf of the MFA, doing an excellent job and are thanked for their support in taking on the challenge
- · We also thank Appin, Mt Annan, Oran Park, Tahmoor and St Marys Eagle Vale for hosting the MiniRoos Gala Days – positive feedback was received regarding each of the host venues and we thank them all for their significant work in providing a positive experience for all participants and their families

- · The introduction of the U13 and U15 Girls' competitions, and Girls-only MiniRoos competitions, were all a great success and hopefully will continue to grow in the years ahead
- · A big congratulation goes to the Narellan U17/1 side who took out the 2019 Champion of Champions Under 17 tournament – a great result and one in which they represented MFA and their Club with respect, and we are all supremely proud of their achievement

We take this opportunity to thank all the Clubs for their support of the MFA, and for the extraordinary work that each volunteer does for each of their Clubs. It can be sometimes be a thankless task leading and driving football at Club level but know how much the MFA appreciates all your contributions and the hard work you each do.

We cannot ignore the support of all the Players, Coaches, Managers and Volunteers, whom without, this great game would not exist.

We also acknowledge the great work that the Local Competitions Committee have continued to provide throughout the season. Each of them gives up so much of their own time to ensure that the MFA competitions are run as effectively as possible.

Office staff (Michelle and Norm) dealt with a plethora of calls and enquiries during the season and continue to be of great support to the MFA.

A big thank you to Salv as General Manager who has assisted the Board in driving their strategic vision and in supporting and implementing various initiatives that have improved the overall football experience in MFA for all. And finally, a thank you to the Board for their support, guidance and vision during 2019.

We now look forward to season 2020, armed with a new Constitution and new Football Competition Regulations to help us take our great game, in this great Association, to even greater heights going forward.

# FOOTBALL MANAGER'S REPORT

#### AS AN INTRODUCTION, I WOULD LIKE TO THANK ALL THE CLUBS, PARENTS AND PLAYERS WHO ARE INVOLVED WITH THE PROGRAMS.

I would also like to thank the casual coaches, representative coaches and volunteers who assist with Coach and Player Development - your efforts are appreciated. Coach and Player Development is one of the most important areas of our game especially as we strive to grow and attract new families to the sport. A proven method of attracting families is by providing effective coaching and creating a good, safe and enjoyable learning environment for the children.

#### COACH DEVELOPMENT

#### Courses

In 2019, the MFA advertised over 20 courses to help upskill coaches at all levels, with 195 coaches attending and gaining accreditations which will assist them to coach their teams more effectively through structured training sessions.

#### **Club Visits**

This season the MFA coaching staff were able to carry out 10 club visits to assist in Coach development at club level. I must thank all the clubs who took part in this initiative as well as the Macarthur Rams Youth and MFA representative coaches for their support.

#### **Club Coaching Coordinator Program**

The Club Coaching Coordinator (CCC) program was reignited in 2019 and will be a key focus for the MFA over the next five years. The MFA aims to upskill nominated CCC's so they can deliver coach education and development programs, such as the MiniRoos Certificate. We are looking forward to developing this program with local clubs.

#### REPRESENTATIVE TEAMS

Thanks to the assistance of the MFA, representative team coaches John Parcio (U9), Josh Domanski (U10). Adam Lovering (U11), and Vicente Benditti (U12) all completed the Advanced Coaching C-License in 2019. The support provided by the MFA is truly appreciated and will only serve to help provide quality coaching for our young footballers.

#### Skill Acquisition Program (SAP)

At this level the focus remains on the development of the four 'core Skills' - First Touch, Striking the Ball, Running with the Ball, and 1 v 1. Coaches work to a program in which the four core skills are rotated within cycles with variations based on the "moment" in the game when they might be used. These are spread throughout a 30week season which includes three training sessions per week. The MFA SAP are pitted against the best players of their age group throughout NSW.

Overall, we are proud of the progress players made throughout the season.

#### Association Youth League (AYL)

The AYL program is deliberately set out to develop players on a holistic level. Coaches work hard to develop footballers who are technically, tactically, physically and mentally adept and will consistently espouse the values of sportsmanship and humility.

#### Team Report: U13

Coached by Scott Hepburn and assisted by Arvind Lal and Brevis Ashton.

In a challenging year, the boys transitioned from SAP or club football into the representative scene. It was indeed a sharp learning curve for both staff and players. Despite their final position on the table (9th) the squad had improved significantly throughout the competition and really displayed some good football culminating in many turnarounds and close results in the second round.

#### Team Report: U14

Under the guidance of Jamie Penman and ably assisted by Damian Bootsma, the U14 team managed to win the Grand Final after showing great attitudes toward their development and commitment to the squad throughout the year.

#### **Association Development Program (ADP)**

This program was set up to assist the football development of the MFA club players who might want to get some preparation training for representative team trials and for players who may just want to do some extra training on top of their club training. The twenty (20) week program saw a record 228 participants over two centres in 2019. The program session content is based on the four core skills - First Touch, Striking the Ball, Running with the Ball and 1 v 1. Ball mastery and small sided games are regular features in each session.

Since its inception the program has resulted in:

- · 55 players transitioning to MFA SAP;
- · 4 players transitioning into the AYL;
- · 14 players transitioning into the Rams SAP;
- · 4 players transitioning into the Rams Youth;
- 15 players moving into the Girls Skill Acquisition Program (GSAP); and
- · 4 players transitioning into Rams Women's Youth.

#### **PARTICIPATION**

The MFA ran a variety of participation programs over the course of the year with the aim of introducing new players to the game, providing alternative coaching and training and professional development for the MFA coaching taskforce. Over 350 boys and girls took part in MFA programs throughout the year.

# **MARKETING SNAPSHOT**

#### THE MACARTHUR FOOTBALL **ASSOCIATION AIMS TO PROMOTE AND** CELEBRATE OUR GAME TO ENGAGE MORE PEOPLE THAN ANY OTHER CODE.

Growing the Girls Game is a primary focus for the Association, with the introduction of Girls-only MiniRoos leagues a key strategy to attracting and retaining young girls in our sport. The Association partnered with Football NSW to include a promotional advertising feature across local newspapers to bring community awareness to the new leagues. A total of 17 Girl's-only MiniRoos teams were established this year, with almost 700 girls under 11 registered in 2019.





Football NSW again supported Associations via the annual 'Play Football' marketing campaign, with a focus on promoting via digital and social platforms. The campaign was primarily targeted at encouraging existing members to return for season 2019, however the Association also invested in online advertising to reach a new audience. Overall participation surged passed

10,000 winter players for the first time in the history of the Association, recording a 5.2% increase from 2018.



Once the season began the focus shifted to creating engaging content that celebrated the weekly participation of the Macarthur community in our game. The Association's 'Weekly Spotlight' and 'Team Talk' segments again proved to be popular content on Facebook and Instagram. Each club was included in these segments, which saw the MFA Media Team promote weekly MiniRoos matches and catch up with teams for a post-game interview.

One of the most popular and powerful images of 2019 came in Round 1. Ingleburn teenager **Tamara Robbins** was awarded the Football NSW Fair Play Award for an act of true sportsmanship, after she ran to console an injured Eschol Park Goalkeeper (Jemma Warburton). The image, captured by Ingleburn photographer Wim Kantona) sent the Macarthur Football social media into a frenzy.



The McDonald's M-League took centre stage as Macarthur's premier senior competition, with the introduction of a weekly 'Match of the Round' highlights reel. Highlights were also produced and shared for all Division 1 and 2 Grand Finals.

### MACARTHUR RAMS **MEN'S REPORT**

#### THE MACARTHUR RAMS MEN FOOTBALL **CLUB CONSISTS OF THREE PROGRAMS:** SENIORS, YOUTH AND THE SKILLS **ACQUISITION PROGRAM (SAP).**

In 2019 The Seniors were in the Football NSW National Premier League 2 (NPL2), Youth were in NPL1 and SAP have the one program for all licensees.

The Macarthur Rams Men's are here to support Representative Football in the Macarthur Region and have open trial days every year for players to come along to trial for selection.

#### SKILLS ACQUISITION PROGRAM (SAP)

Over 300 players from the Macarthur Region trialled in October 2018, for the 88 (72 Boys and 16 girls) available positions in the 2019 Macarthur Rams SAP Squads. A total of 75 were selected, 72 boys and 3 girls.

The concept behind the SAP is exactly as the name states; it's about players acquiring the skills required to play football competitively as they progress through their career into youth and ultimately into senior programs.

Scores are not recorded for the SAP, however the young players hit the season running and were successful more often than not. The U9s started learning the national football curriculum under the guidance of former Socceroo Brett Emerton, whom was in his first year as a head coach with Rams. The U10s through to U12s continued their training, complying with the national curriculum delivered by fully licenced coaches.

An enjoyable season was had by all and we even had a request from Advertising Company Banjo Bastian to use photos containing six of our SAP players in a Clubs NSW promotion, so we may see some of our young players in advertising sometime soon.

#### YOUTH PROGRAM

The Youth season started off well with the youth teams attending a pre-season camp, where they played a pre-season trial against the Wolves. The main idea of the camp was team building, which saw the players get to know more about their team mates to help them work together through the 2019 season.

The start of the season saw the Youth Program up against some very tough competition, though the youth teams faired very well in pre-season trials, it was difficult to secure wins and points from the outset of the season.

#### **SENIORS PROGRAM**

The seniors had a very difficult season with all teams playing well, however just couldn't quite convert that to goals and it just wasn't to be the senior's season in 2019.

Whilst it was a very hard year for the senior's program there was some very good news for one Rams player. Cooper Hannigan (19 years old) was offered a position in Lincoln City's under 23's team for 2020. We wish Cooper the best of luck with his career and will follow his progress with interest.

The Macarthur Rams Men are looking forward to 2020 and are going to be working hard for the Senior's to get back into NPL2, the Youth to get back into NPL1 and the SAP to learn, enjoy, have fun and play the fantastic game of football for life.







### MACARTHUR RAMS **WOMEN'S REPORT**

#### **2019 SEASON REVIEW**

MACARTHUR RAMS WOMEN'S FC REPRESENTED THE MACARTHUR REGION IN THE FOOTBALL NSW WOMEN'S **NATIONAL PREMIER LEAGUE 1 WITH TEAMS COMPETING IN THE UNDER 14S.** 15S, 17S, RESERVE AND FIRST GRADE COMPETITIONS.

#### SENIOR GRADE

The First and Reserve Grade teams finished the season in the mid-table positions of sixth and eighth respectively resulting in an overall seventh place in the club championship table. This was a disappointing result for the club following a second-place finish in the 2018 season.

The performance of both teams was affected by the loss of key players through both transfers and injury with Reserve Grade players regularly playing First Grade football or backing-up following their Reserve Grade matches.

Following a lack of success in the first eight matches of the season the club appointed a new coach to the Reserve Grade team. Results improved but the team was unable to advance to a top five position.

First Grade and local player Rosie Galea was selected for Australian representation in the Young Matilda's. What a highlight for Elizabeth Ralston as well, earning selection in the Matilda's squad in preparation for the World Cup. Ralston was a squad member who participated in matches against the USA while working towards the World Cup campaign in France.

#### **NPL YOUTH PROGRAM**

Participation in the National Premier League Women's competitions also involves the extremely important youth program, which includes Under 14, Under 15 and Under 17 youth teams in the Division 1 League.

Year by year the standard of play in the youth arena continues to excel on a technical, speed of play, and

physical attributes basis. This year was an especially competitive and tough ask for Macarthur Rams and our three teams were tested week in and week out.

Of note for the 2019 season was the introduction of several players moving from the MFA local competition. The experience gained was invaluable for these players and will certainly prepare them for the upcoming 2020 season.

A couple of very worthy accomplishments for some key Rams Youth players was selection for Football NSW State Teams, which competed in the 2019 National Youth Championships held at Coffs Harbour in July. Congratulations to Jorgi Webb (Under 14 Football NSW Country Girls) and Camille Falshaw (Under 15 Football NSW Country Girls).

The support of all MFA member clubs in the development of their young female players is welcomed by Macarthur Rams and you should all be especially proud of the contribution made to your players football development.

#### GIRLS SKILL ACQUISITION PROGRAM

2019 was another successful season for our young girls in the Macarthur Rams Women Skill Acquisition Program (GSAP). GSAP has been running for four seasons now, the first two seasons under the MFA banner and the past two seasons have been under Macarthur Rams Women FC. The program consists of four teams -U10 through to U13. U13s use a 3/4 size field and is considered a transition year in preparation for NPL, beginning in U14.

Macarthur Rams Women GSAP is comprised totally of girls from local Macarthur grassroots clubs. Women's football is rapidly gaining momentum in Australia, and Macarthur Rams Women FC is at the forefront of young girl's football development. Our coaches are fully accredited and all share the same passion for the continued growth of our sport. Each week, we are showcasing the incredible talent that our area has to offer. We have facilities second to none and are the only club that afford our players proper referees at all our home games.

Due to the support and infrastructure from our club and the talent being nurtured, identified and presented to us from local clubs, we are the envy of most other GSAP clubs.

Macarthur Rams Women FC would like to mention two young ladies within our program that have reached milestones in their very young careers. Ellie Leigh Lontis (U13) is our longest serving player at this level. Ellie started her career in U9 with boys at Macarthur Rams and she will be progressing to NPL1 U14 in 2020.

**Rebecca Norman** has been playing in GSAP since the program's inception. Rebecca started her career with the very first U10 GSAP team and will also be progressing to NPL1 U14 in 2020.

To conclude, I would like to express our greatest thanks to our club, Macarthur Rams Women FC, and

all involved, for their continued support and guidance for helping us achieve the levels of quality we have with our program and its players. Also, a massive thank you goes out to Macarthur Football Association and all local clubs for helping to create, identify and encourage young girls to pursue a career in professional football and using Macarthur Rams Women FC for their pathway to the top.

The future for women's football is very bright.

#### (a) Property, Plant and Equipment (PPE)

PPE are carried at cost less, where applicable, any accumulated depreciation. The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use. The gain or loss on disposal of PPE is determined as the difference between the carrying amount of the asset at the time of disposal and the proceeds on disposal and is included in the results of the Association in the year of disposal.

#### (b) Income Tax

The Management Group are of the opinion that the Association is exempt from Income Tax under the provisions of Section 50.45 of the Income Tax Assessment Act 1997 and consequently no provision for taxation has been raised in the financial statements.

#### (c) Employee Benefits

Provision is made for the Association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits have been measured at the amounts expected to be paid when the liability is settled.

#### (d) Leasehold Improvements

Leasehold improvements to Lynwood Park are being amortised over their estimated useful life. Although the Association does not currently have a lease for this ground, it is reasonably expected that its right to use the ground will continue. The financial report has been

prepared on the basis that the Association will continue to enjoy the benefit of the leasehold improvements.

#### (e) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of six months or less.

#### (f) Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. Interest revenue is recognised when received. Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt. All revenue is stated net of the amount of goods and services tax (GST).

#### (g) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Tax Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the assets and liabilities statement are shown inclusive of GST.

#### (h) Trade and Other Receivables

Trade and other receivables include amounts due from customers for goods sold and services performed in the ordinary course of operations. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

#### (i) Trade and Other Payables

Trade and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period, which remain unpaid. The balance is recognised as a current liability and is subject to normal credit terms (30-60 days). The balance is not interest-bearing.







# Total Male Player Numbers By Club - 2019




# Total Female Player Numbers By Club - 2019




# Total MiniRoos Players By Club - 2019








# Total Senior Players By Club - 2019
