### CHAIRMAN'S REPORT

WELL THE 2020 FOOTBALL SEASON IN MACARTHUR HAS DEFINITELY BEEN **LIKE NO OTHER WITH THE COVID-19 GLOBAL PANDEMIC SENDING THE COUNTRY INTO LOCKDOWN IN MARCH** AND PUTTING THE SEASON IN SERIOUS **DOUBT. BUT WITH RESTRICTIONS** LIFTED, AND THANKS TO OUR GREAT **STAFF, OUR FANTASTIC MEMBER CLUB COMMITTEES AND VOLUNTEERS, OUR** WONDERFUL MACARTHUR REFEREES AND SUPPORT OF CAMPBELLTOWN, CAMDEN AND WOLLONDILLY **COUNCILS, WE WERE ABLE TO KICK-OFF** THE SEASON AS SOON AS PERMITTED IN THE FIRST WEEK OF JULY, WHICH WAS A HUGE ACHIEVEMENT BY US ALL.

The shortened season faced many challenges though and a monumental effort was needed by all to get a lot of midweek games played, which was key to completing the season during a great October long-weekend with Grand Finals at Lynwood Park and Ron Dine Reserve. I would like to thank Camden Tigers for hosting Grand Finals for the MFA this season.

Although a slightly shortened season in the end by the number of games played, I would like to acknowledge the fantastic ongoing support from our sponsors this season: Wests Group Macarthur, Ottimo House, McDonald's in Macarthur, Marsdens Law Group, Guzman y Gomez, Deploy Football and Stanno. We thank them for their great support of Football in the Macarthur region. It was unfortunate that due to restrictions and the risk factors of the pandemic, the hard decision was made not to go ahead with our major MFA events this season. We will plan for all our events, such as the M-League Awards Night and City v Country Charity Round, to run in 2021.

This year has once again proven to be an extremely busy but collaborative one off the field. With the MFA Board, Staff and Member Clubs working to implement further strategies and changes to improve and build the MFA into 2021 and beyond. We saw our new Club the Gregory Hills Stallions come into the competition playing out of Cunningham Park. We thank Renato Cocchietto and his Committee for all their time and effort in building a successful club. Football in the Camden LGA has been bolstered with Camden Council delivering a great new Synthetic field at Nott oval, home of Narellan Rangers, which has just been handed over. We thank all involved especially, Mayor Theresa Fideli and the Camden Council. This year we also launched the new license set-up with

the Men's and Women's M-League competitions, which was a big success. Another success story is growth in our Girls-only MiniRoos Leagues, which is fantastic and an initiative we will continue to push. We also commenced an extensive representative and coaching review earlier this year and I would like to thank Salv and Norm especially who led the review as well as all others involved. There were over 30 findings which will ensure, moving forward, that within the coaching and representative arm of the MFA, major improvements will be achieved in the coming seasons. Due to the pandemic the MFA SAP, AYL, Macarthur Rams Men's/Boys, Women's/Girls programmes, and Camden Tigers NPL teams, all had reduced seasons, which we hope are back to normal next season. I would like to thank both Gordon Sneddon and John Murtagh and their committees for running the programmes. We also continue to work closely with the new A-League club Macarthur FC, the Bulls, in looking at community projects and programmes to be implemented together. We are extremely excited about the upcoming season kick-off next month - Go the Bulls!

It was another successful season with our MFA media team and the inclusion of Jum Media to the team this season was great. I would like to thank the owners James and Mandy Cassel. They worked with the Office and our clubs throughout the year and, for the first time, we could live-stream M-League games as well as the full weekend of first division Grand Finals, which was a big hit. We were advised that family and friends were watching overseas and interstate which was fantastic to hear. I would also like to acknowledge our fantastic and hardworking photographers John Humphreys and Jill Bennett who took magic photos of our minis and M-League players during the season. I would also like to thank Mike Shean from Macarthur Sports Radio who did the commentary for all Division One Grand Finals working with Jum Media on our livestreaming which really added to the coverage. I would also like to thank Derek Meechan and the Macarthur District Football Referees Association as well as all our Macarthur Referees for the season. The coverage in a difficult season was outstanding again. I would also like to acknowledge Paul Neaves who is in his 40th season as a local referee which is an outstanding effort and commitment to the game.

A big thank you to our MFA staff who have managed the organisation extremely well in a tough and hectic year. Our General Manager, Salv Carmusciano who guided us through the shutdown period, dealing daily with all levels of Government, FFA and Football NSW to get us to a start date as well as running the MFA. Our Competitions Manager, Steve Carroll, whom at short notice, was able to construct all competitions working closely with the CMC, referees, and the clubs, culminating in a fantastic long-weekend of Grand Finals. Our Football Manager, Norm Boardman, whom under very difficult circumstances due to the pandemic and restrictions was still able to deliver coaching courses and do club visits which was a fantastic outcome for the MFA. Norm also co-managed and ran the representative football and coaching review, which was a major job, and we thank Norm for that. Norm has decided to move on and take up a new challenge and we wish Norm all the best and thank him for what he has achieved over the years with us at the MFA. Norm was instrumental in setting up the fantastic Association Development Programme (ADP), the MFA SAP and the Association Youth League (AYL) programmes. In addition to his portfolio with the MFA, Norm also coached our Macarthur Rams Women to a memorable Grand Final win in 2018. We also extend our thanks to our Office Manager, Michelle Fulcher, for the administration support throughout the year and ensuring the office ran efficiently, and to our newest staff member, Josh Tungcab, for your contribution throughout the year and delivering the first MFA summer six-a-side competition earlier this year.

### GENERAL MANAGER'S REPORT

#### WELL, THAT WAS DIFFERENT.

To say that the 2020 season challenged us would be an understatement. There was a lot of uncertainty throughout the year as we faced a global pandemic. Yet, we are so proud of how the Macarthur Football Community responded in the face of adversity. It is important to acknowledge the many passionate, committed club volunteers for going far above and beyond in this season like no other. These individuals are the heart and soul of our great game and we cannot thank them enough for their energy, enthusiasm, and hard work. It is also important to acknowledge the leadership of Football NSW during this period. The MFA thanks CEO Stuart Hodge and his team for advocating strongly for the game and ensuring we were all ready to return to play.

In February, the MFA launched the 2020 – 2025 Strategic Plan for Football in Macarthur. The plan reflects the game's main strategic agenda over the next five years, including the issues and opportunities ahead of us. Whilst we may have experienced an interrupted community football season, we continued to work hard on several aspects of the plan, including:

#### 1. IMPROVING THE DELIVERY AND MANAGEMENT OF THE LOCAL COMPETITION

The fact that a season could be played during such unprecedented times was an achievement in itself. We would like to acknowledge and thank the MFA Competition Manager Steve Carroll, Administration Officer Josh Tungcab, the Competition Management Committee, the Judiciary Committee, and the Macarthur District Football Referees Association for their professionalism during such difficult circumstances. These individuals and groups weathered all storms and worked incredibly hard to deliver exceptional customer service and ensure the community had the opportunity to take the field in 2020. Ahead of the 2020 Season, the MFA worked closely with its members to update the Competition and Judiciary & Discipline Regulations. The new Regulations were passed at a Special General Meeting and quickly adopted, with rules and processes strictly enforced. Overall, we believe decisions were consistent, fair, reached quickly and communicated effectively. We will continue to review our performance frequently to ensure we deliver excellence in competition management consistently. We feel we are on the right track, having received an overall member satisfaction score of 79% for the 2020 Season.

#### 2. GROWING THE GIRL'S GAME

Despite a compromised year, we were delighted to see more female teams than ever before. Much of this growth was attributed to the Girls-only MiniRoos Leagues, which saw a significant increase in the second season of this initiative. We will look to build on this momentum heading into the 2023 FIFA Women's World Cup on home soil.

#### **3. RELAUNCH OF THE M-LEAGUE**

The M-League underwent significant review during 2019, with many changes introduced to create separation between community football and Macarthur's Premier League.

We welcomed Ottimo House as the new naming rights sponsor and established a clear identity for the League with a new logo created.

The Men's Competition increased from six to eight squad-based teams under a new club-license arrangement. The U21's were also introduced to replace the previous third Men's division. Several rule changes were also made to improve the standard of the competition.

Finally, we increased our investment in marketing and promotion of the Men's and Women's League via social media, including the successful launch of live streaming, which was well received.

#### 4. REVIEW OF REPRESENTATIVE FOOTBALL AND COACH DEVELOPMENT

The MFA embarked on this extensive review during the suspension of community football, with the overall aim of providing the best possible development ecosystem that encourages and supports players and coaches to forge professional careers in the sport. The comprehensive process included a consultation phase with members of both community and representative football within and outside of Macarthur. A Working Group was established to consider the findings of the review and draft a set of recommendations for consideration. A Final Report was published, with over thirty recommendations made for consideration. This review process ensured we could effectively define the objectives within the Pathways Pillar of our strategic plan.

Running the MFA in 2020 was certainly challenging, particularly during the suspension of football. With the aid of Government grants and the sound management of expenditure, a small operating surplus was achieved. More importantly, the MFA was able to secure significant fee reductions this season to support our member clubs.

In what was a difficult season for many, the MFA was fortunate to retain the support of our partners: Wests Campbelltown, McDonald's in Macarthur, Marsdens Law Group, Guzman y Gomez, Deploy Football, Ottimo House, and Stanno. We thank our partners for their support of our great game. We would also like to acknowledge the support of Wollondilly Shire Council, Camden Council, and Campbelltown City Council for continuing to invest in our game and community. It would be remiss of us not to highlight the generosity of Camden Council this season, agreeing to waive ground hire fees for all winter users. We thank Camden Council



Mayor Theresa Fedeli for this kind gesture and support of the Camden sporting community.

On a personal note, I would like to thank the wonderful staff at the MFA for their efforts throughout the year. It was certainly a tough start with everyone required to make sacrifices during the suspension of football. Their service to the game during this difficult season was incredible.

I would like to take this opportunity to wish outgoing Football Manager Norm Boardman all the best in his next challenge and thank him for six years of service to the Macarthur Football Family.

I would also like to acknowledge and thank the many volunteers that supported the MFA during the year. We cannot do it without you.

Finally, to all members of the MFA Board for affording me the opportunity to continue to serve the game in Macarthur and for their staunch support and counsel they have offered over the year. They are a massive contributor to the standing MFA has in the broader football community and I look forward to another year of serving with them in 2021.

It is acknowledged that in order to get the best out of the compromised 2020 season MFA needed the support of all Clubs to allow their respective fields to be made available for an extraordinary number of midweek matches, and this occurred without complaint. Obviously we were all looking to provide our players with the most number of matches possible, but first and foremost we were all wanting the football experience of each of our members to be as positive as possible in a year of uncertainty. We think that collectively we achieved this goal as by and large the feedback has been positive and furthermore we were able to give the community what they wanted - team activities in a year that anything of this nature might have been deemed as too difficult to accomplish.

We also thank the three local Councils for agreeing to extend the winter hire of fields so that the season was not compressed any more than it was - their support too was invaluable.

It goes without saying that the Macarthur Referees were very accommodating in our plans and delivery of football, and a big thank you goes out to each of their members for their invaluable support and dedication in 2020.

A significant amount of planning went into developing the season and we at different times felt that the virus concerns may have closed us down at any minute, but we overcame these, and were able to deliver football weekly, culminating in a very successful Grand Final weekend to each of our members.

As to be expected during this compromised season, player registration numbers were down on 2019, but not catastrophically which was pleasing. 110 Competitions were still created this year accommodating 810 teams, including more female teams than ever before with 108.

In our Premier Competitions, the Ottimo House M-League, both Gunners and Tigers repeated their form of last year in taking out the Men's and Women's First Grade titles respectively. Congratulations to both Clubs on their consistency and achievements.

Oran Park proved to be worthy challengers to Gunners

in taking out both the Premiership and Championship in the Reserve Grade.

The first year of the 'Colts' was a great success. Tigers were run-away winners in the Premiership race but fell short of taking out the double with a good win to Harrington United in the Grand Final to secure the Championship. The live streaming of all Division One Grand Finals was an instant hit and from feedback received, the MFA is on a winner with this initiative. Live steaming will certainly continue into 2021 and we hope to deliver even more coverage than ever before.

Over the October long-weekend, we were treated to a plethora of great matches both at Lynwood and at Ron Dine where Camden Tigers hosted a very successful event. It was a full-on three days of Grand Finals which were played in oppressive heat, but that didn't stop the celebrations happening and all matches were played at very high standards.

Unfortunately, we were unable to provide Gala Days this season, but our 'MiniRoos' did have an opportunity to play an extra round of football that was embraced by many of our Clubs. Rest assured the Gala Days will be back in 2021 (cessation of health crisis permitting).

Some other highlights of the 2020 season included:

- Gregory Hills FC joining the competition (participated in MiniRoos competitions);
- St Mary's Eagle Vale making a successful transition from AAW2 to the Women's M-League Competition; and
- New Competition Regulations introduced and apart from a possible tweak in certain areas, they seemed to work well.

Here's hoping that everything will be back to normal in season 2021 and a full calendar of matches will be played in our winter season window.

Unfortunately, COVID-19 seriously affected everything I normally do from running courses to kick starting the Club Coach Coordinator (CCC) programs and providing club visits throughout the year.

#### **COACHING COURSES**

Due to the pandemic causing the cancellation of most courses, the numbers are well down on last year. Having said that, some courses were started, and I was able to finalise some by providing individual assistance at training during the candidate's sessions to help them finish their course.

#### **CLUB VISITS**

This year I was able to conduct several club visits following the directive that we could training in larger groups but once again this was very difficult to do as a large part of the season was wiped out.

Eschol Park, Camden Falcons, Burragorang, Camden Tigers, Collies and St Mary's were all visited and some on a few occasions.

During these visits I usually worked with the coaches on constructing effective training sessions with their teams and aimed at that team's level of understanding. A variety of topics are generally covered.

#### **CLUB COACH COORDINATOR PROGRAM**

In a year where we were looking to really get this going a lot of interest was lost from March onwards causing me to think outside the square. This encouraged me to share videos and other online material with the group.

#### DEVELOPING A QUALITY YOUTH DEVELOPMENT ENVIRONMENT

#### Trials

Trials for MFA SAP & AYL were held in October 2019 with approximately 40 attendees for each SAP age group and 35 for each of the Youth age groups. Pleasingly, 14 MFA players graduated to the Macarthur Rams in 2020.

#### **Pre-season Camp**

February saw the MFA SAP and AYL attend a camp in Gerringong. The players were treated to quality nutritional meals, training on quality pitches, and team bonding exercises whilst in a safe, fun and enjoyable learning environment.

#### **CREATED RESOURCES FOR MFA SAP AND AYL**

All players in both groups were provided with Player diaries which they were required to fill out with their reflections on training and games so they could easily recall information that they might receive at training and in games they also had to identify two things they did well and two things they could improve. A video of Home Training activities was also created for the players to do throughout the pandemic.

With the season being severely disrupted, it is difficult to work out what positions the AYL teams would have been on the ladder given they played NPL sides as well as their own competition games in their "bubble" during the pandemic. Our best result was against Bonnyrigg (NPL 1 club) where we won two, drew one, and lost the other game.

The players would normally have mid-year and end of season parent / player / coach interviews to discuss their progress but this year we held the interviews towards the end of the season.

#### ASSOCIATION DEVELOPMENT PROGRAM

This program has over 200 kids participating and by the very nature of feedback, it is hugely successful and highly popular. We have engaged the services of 20



coaches ranging in experience and with varying levels of accreditation, all of whom have performed well in the program. This includes NPL players both male and female as well as AYL and NPL coaches. 25% of the coaching workforce are female.

All players are assessed at 'games nights' approximately every five weeks with focus on technical ability related to their age group and a report is collated at the end of the 20-week program. Reports are sent so parents can track their child's progress. Rams' coaches attended for talent spotting with six players being identified and invited to train with the Rams SAP.

Once again, thanks for all of your assistance and I would like to thank Board Members past and present as well as the other office staff for their support, especially Michelle who goes above and beyond week-in, week-out over a long time to do whatever is needed to help our great game in the Macarthur.

## MARKETING SNAPSHOT

#### THE MACARTHUR FOOTBALL **ASSOCIATION AIMS TO PROMOTE AND CELEBRATE OUR GAME TO ENGAGE** MORE PEOPLE THAN ANY OTHER CODE.

Growing the Girls Game is a primary focus for the Association, and in 2020 we saw more female teams than ever before. The Girls-only MiniRoos Leagues, introduced in 2019 as a key strategy to attracting and retaining young girls, grew from 17 to 28 teams despite the COVID-19 pandemic. The Association partnered with Football NSW to include a promotional advertising feature across local newspapers to bring community awareness to the new leagues.

Football NSW again supported Associations via the annual 'Play Football' marketing campaign, with a focus on promoting via digital and social platforms. The campaign was primarily targeted at encouraging existing members to return for season 2020.

Once the season began the focus shifted to creating engaging content that celebrated the weekly participation of the Macarthur community in our game. The Association continued to focus on MiniRoos with our 'Weekly Spotlight' and 'Team Talk' segments again proving to be popular content on Facebook and Instagram.

The Ottimo House M-League again took centre stage as Macarthur's premier competitions. The MFA welcomed professional film crew Jum Media in 2020 and increased the coverage of the M-League as a result. Highlights of 14 Men's and 14 Women's First Grade matches were produced and shared on Facebook weekly, as well all four First Grade semi-final matches. Live streaming was also introduced for the first time during the season and it did not disappoint.

In light of restrictions on social gatherings due to the COVID-19 pandemic, the MFA took the unprecedented step of scheduling live streams of all 20 Division One Grand Final matches across the October long-weekend. This proved an overwhelming success, with over a quarter-million people reached across the three days.



The 2020 Community Football Season concluded during a very hot October long-weekend with 45 Grand Final matches played across two venues. ## **MACARTHUR RAMS MEN'S REPORT**

#### THE MACARTHUR RAMS MEN FOOTBALL **CLUB IS THE REPRESENTATIVE PROGRAM OF THE MACARTHUR ASSOCIATION** PLAYING IN THE FOOTBALL NSW PREMIER LEAGUE.

Currently there are just under 200 players in the Seniors, Youth and Skills Acquisition (SAP) Programs.

#### **SENIORS**

The Seniors Program structure was changed during 2020 to only include the First team and the Under 20s, with the Under 18s moving into the Youth Program.

Two games into the 2020 season saw the Rams at the top of the club championship table before the season was abruptly interrupted by COVID-19, which resulted in no games played for 4 months, some players leaving the club due to COVID-19 and work commitments.

This break was followed by a second revamped competition which saw fewer clubs involved and resulted in an 11-game season. Promotion and relegation were also removed for the 2020 season.

A new coach, new team and COVID-19 had an impact on the return to competition with the team improving and obtaining better results as the season progressed.

#### YOUTH PROGRAM

The Youth Program comprises of the Under 13's, 14's 15's 16's and, for the 2020 season, the Under 18's were moved into Youth also.

COVID-19 had a large impact on the Youth Program, however the coaches embraced the use of technology holding weekly video meetings, assigning home training programs, and having players record and post their progress and achievements on closed social media groups for review by the coaches, however there was nothing like seeing the enjoyment on players faces as they returned to the field, albeit under social distancing measures.

The Youth Season consisted of 4 smaller competitions, 3 games in First competition, 11 games in the second, 6 games in the 3rd competition and 5 games in the 4th competition, with the 3rd and 4th competitions playing clubs in close proximity.

Promotion and relegation was removed from the 2020 season, despite a full season being played.

The majority of teams finished the season in either 1st or 2nd spot on the ladder of the final competition, with the U14's coming 4th, showing a good improvement during the season.

Justin Mickan, the Youth Program Technical Director, held a 'masterclass' for local coaches during the season where they worked on the development of training in small spaces. A huge success and we will see more of these types of events in the 2021 season.

#### SKILLS ACOUISITION PROGRAM (SAP)

The SAP consists of Under 9s, 10s, 11s & 12's. Though the season started off well for the SAP, they too were not immune to COVID-19.

The Coaches and officials also took to technology and ran training programs over video to help develop and keep the players motivated during the lockdown period.

Upon their return to games the SAP played well and were extremely competitive against opposition. We look forward to seeing these players progress through the teams at Rams.

Along with the players efforts and enthusiasm what really stood out was the support, effort and adaptability of the parents, getting the players to training and games with very little notice, supporting the canteen, setting up and packing up the grounds in a logistically challenging year, they should be very much congratulated.

#### IN CLOSING

A very challenging year that really brought out the best in the Rams players, the Rams Families and Rams Officials. Anyone involved can hold their head up high and proudly say "I was with the Rams in 2020".

#### WELL JUST LIKE EVERYBODY ELSE INVOLVED IN FOOTBALL, WHAT A DISRUPTED 2020 SEASON IT WAS!

With the COVID19 restrictions, a cessation of football activity for months, a return to a disjointed amended draw and finally a return to a somewhat normal draw certainly brought its challenges. As in the past, the club fielded teams in the National Premier League 1 competitions in both senior and youth, together with our Skill Acquisition Program (GSAP) in the Football NSW family.

#### **1ST AND RESERVE GRADE**

Each year the strength and competitiveness of the National Premier League 1 seems to increase and 2020 was no exception.

Major benefits of our senior program is the experience we have amongst our ranks with ex-Matildas and W-League players on the roster. This allows us to develop and provide invaluable knowledge to our younger players who come into senior football.

Looking at the league table, it is not our best year but highlighted several areas we can address to ensure the future and ongoing success of our squads. These have already been identified and implemented now for the 2021 season, so an early start is already on the way for next season.

Again we have several senior players competing in the W-League and then returning immediately to our National Premier League for the winter season. Congratulations to Sham Khamis, Leena Khamis and Patty Charalambous for their campaign with Canberra United during the last W-League and then proudly being a Macarthur Ram straight after.

We cannot leave off without acknowledging what a valuable member Leena Khamis has been to football in general and particularly Macarthur Rams. From

a youth player at Rams, to a long serving Matilda player, international club play in Denmark, inaugural W-League player and scoring the W-League's first ever goal. I am sure Leena does not mind me labelling her an "experienced" player and we congratulate her on securing a 2021 contract again with Western Sydney Wanderers.

#### NPL YOUTH

As part of our commitment to NPL, Macarthur Rams also fields teams in the NPL Youth – Under 14, Under 15 and Under 17.

The competition in all of the above leagues is ultra competitive and brings out the best in our up and coming players. Although not amongst the leaders ladder wise in the competition, we were able to introduce all squads to the culture and way of football at Rams with an aim of lifting technical and physiological attributes for their future in the game.

The COVID19 season probably affected our NPL Youth teams more than the other squads. With a cessation of training and playing, returning to a rather arbitrary temporary competition draw outside their league and then a resumption to a scheduled draw late in the season. The teams finished their 2020 commitments on November 1 and had to arrive on November 2 for 2021 selection trials! A major thank you to players, parents and team officials in dealing so well with this season and we can only hope 2021 brings us a much better scenario.

#### GSAP (GIRLS SKILL ACQUISITION PROGRAM)

Our GSAP teams (Under 10, Under 11, Under 12 and Under 13) form the future development program for the club where they are introduced to football at a level more advanced. This is a valuable start for the aspiring Matilda's football careers where they are led by coaches who are all accredited with a C Youth coaching licence. Using the principles of the small-sided game approach, the teams play in an organised league conducted by Football NSW without the use of competition tables and points. This allows players to have many ball touches during their game and work on individual and team techniques without pressure of competition tables. Many GSAP players are advancing into our NPL Youth squads showing how their game has improved by learning at an early age as to what is required to be a talented footballer.

On a general note, every member and family connected with Macarthur Rams Women's FC needs to be recognised for their valuable contribution made in 2020 and how the adverse circumstances were handled. We look forward to welcoming all 2021 members to Rams and the implementation of improvements to all our programs.

#### NOTES TO THE FINANCIAL STATEMENTS

For the year ended 30 June 2020

#### **NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Preparation**

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporations Act of New South Wales and Class Order 11/01. In the opinion of the Management Group the association is not a reporting entity because it is not reasonable to expect the existence of users who rely on the association's general purpose financial statements for information useful to them for making and evaluating decisions about the allocation of resources.

The association has not assessed whether these special purpose financial statements comply with all the recognition and measurement requirements in Australian Accounting Standards.

The financial report has been prepared on an accrual basis and is based on historical costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

#### (a) Accounts Receivables and Other Debtors

Accounts receivable and other debtors include amounts due from members and customers for goods sold and services performed in the ordinary course of operations. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

#### (b) Property, Plant and Equipment (PPE)

PPE are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

#### (c) Income Tax

The Management Group are of the opinion that the Association is exempt from Income Tax under the provisions of Section 50.45 of the Income Tax Assessment Act 1997 and consequently no provision for taxation has been raised in the financial statements.

#### (d) Employee Benefits

Provision is made for the Association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits have been measured at the amounts expected to be paid when the liability is settled.

#### (e) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of six months or less.

#### (f) Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed.

Interest revenue is recognised when received.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

All revenue is stated net of the amount of goods and services tax (GST).

#### (g) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable.

#### (h) Trade and Other Payables

Trade and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association that remain unpaid at the end of the reporting period. The balance is recognised as a current liability and is subject to normal credit terms (30-60 days). The balance is not interestbearing.

### Total Registrations By Club - 2020






### Female Registrations to Overall Player Registrations - 2020




### Total MiniRoos Players By Club - 2020




### Total Youth Players By Club - 2020
