The **MFA Judiciary Committee** comprises of a Chair (JC Chair) and a panel of suitable persons as nominated to, and approved by, the MFA Board from time to time.

The MFA Judiciary Committee has jurisdiction over offences arising from the Competitions where Participants have received, or ought to have received cautions or dismissals.

The **MFA JC Chair** is the key point of contact for all MFA Disciplinary & Judicial matters. The JC Chair liaises closely with MFA Staff, the MFA Competition Management Committee (CMC), the Macarthur District Football Referees Association (MDFRA), MFA Affiliated Clubs, and the MFA Judiciary Committee on a weekly basis.

During the Football Season, the **MFA Judiciary Committee** may be required to conduct Hearings once per week. Hearings are organised by the MFA JC Chair and require a total of three (3) other Committee Members selected from the approved panel to constitute a quorum for a JC Hearing.

Hearings are conducted by the Judiciary Committee at the MFA Office at Lynwood Park. Hearings can also be conducted online if required.
