



## NOMINATION FORM 2025 MFA SPECIAL PURPOSES COMMITTEE

The MFA is now calling for nominations for the following positions for the 2025 Football Season:

- 1) MFA Special Purposes Committee Chair (one position); and
- 2) MFA Special Purposes Committee Member (up to six positions).

The **MFA Special Purposes Committee** comprises of a Chair (SPC Chair) and a panel of suitable persons as nominated to, and approved by, the MFA Board from time to time.

The MFA Special Purposes Committee (SPC) has jurisdiction to hear and determine:

- a) charges of Misconduct and Disrepute;
- b) grievances between Members;
- c) any other matter the MFA Office considers important to the interests of football in the Macarthur region;
- d) any other matter referred to it by the Judiciary Committee;
- e) sanctions on a Club for the misconduct of a team, including when (a) one or more Participants make threats or show force against a Match Official, or (b) Participants engage in violent conduct.

The **SPC Chair** is the primary point of contact for all matters summarised above. The SPC Chair liaises closely with MFA Staff, the MFA Competition Management Committee (CMC), the Macarthur District Football Referees Association (MDFRA), MFA Affiliated Clubs, and the MFA Special Purposes Committee as required.

During the Football Season, the **MFA Special Purposes Committee** may be required to conduct Hearings from time to time. Hearings are organised by the MFA SPC Chair and require a total of two (2) other Committee Members selected from the approved panel to constitute a quorum.

Hearings are conducted by the Special Purposes Committee at the MFA Office at Lynwood Park. Hearings can also be conducted online if required.

All positions on the Special Purposes Committee are voluntary and conclude 31 October 2025. To nominate for a position, please complete this form.
