

Macarthur Football Association Mascot Naming Competition: Terms and Conditions

1. Introduction

These Terms and Conditions govern the “Macarthur Football Association Mascot Naming Competition” (the “Competition”) organised by the Macarthur Football Association Inc (ABN 82 138 352 399) (“Organiser”). By participating in the Competition, you agree to be bound by these Terms and Conditions.

2. Eligibility

2.1. You are eligible to enter the Competition if you are: a **registered member** of the Macarthur Football Association or a registered member of one of the Clubs that are governed by the Macarthur Football Association or a registered participant (including for example, a coach, team manager or volunteer) within the Macarthur Football Association system on the date of entry.

2.2. Employees of the Macarthur Football Association, their immediate family members, and anyone professionally connected to the Competition are not eligible to enter.

3. Competition Period

The Competition starts on **February 29th, 2024, at 9:00 AM** and closes on **March 24th, 2024, at 11:59 PM**. Entries received outside this period will not be considered.

4. How to Enter

4.1. Entries are **only accepted online** through the official competition form at <https://form.jotform.com/MFAMFC/mfamascotname>.

4.2. For your entry to be considered and to be eligible it must answer all questions on the form.

5. Selection Criteria

5.1. A panel of judges selected by the Organiser will evaluate the entries based on the following criteria:

- Originality and creativity of the name
- Relevance to the mascot character and Macarthur Football Association and its values.

5.2. The panel has the absolute discretion to decide to not accept any of the entries received.

5.3 The panel's decision will be final and binding, and no correspondence will be entered into regarding any review of their decision.

6. Prize

6.1. **One (1) winner** will receive a **\$500 voucher** to Alpha Elite Gear.

6.2. The prize is non-transferable and cannot be exchanged for cash or other goods or services.

6.3. In the event that the winner of the Competition cannot be contacted or located, despite all reasonable inquiries of the Organiser, the prize may be withheld or otherwise awarded to another eligible entrant.

7. Intellectual Property Rights

7.1. By entering the Competition, you agree that the Organiser will have sole and exclusive rights to the mascot name and may license, reproduce, modify, publish, distribute, and translate the submitted mascot name in connection with the Competition and the promotion of the mascot and the Macarthur Football Association generally without any consideration or fee payable to you other than the prize referred to in these terms. You irrevocably and unconditionally transfer any and all intellectual property and ownership rights in the mascot name to the Organiser when you submit your entry.

7.2. You warrant that your entry is your original creation and does not infringe upon any third-party intellectual property rights.

8. Disqualification

The Organiser reserves the right to disqualify any entry that:

- does not comply with these Terms and Conditions;
- contains offensive, obscene, or discriminatory content;
- is suspected of being fraudulent or misleading; and/or

- is submitted by an ineligible person.

9. Data Protection

9.1. The Organiser will collect and use your personal data for the purpose of administering the Competition and in compliance with any applicable legal requirements.

9.2. Following the completion of the Competition, any personal data collected for the purpose of administering the Competition will be deleted.

10. Limitation of Liability

The Organiser is not liable for any loss or damage arising from your participation in the Competition, except to the extent that such liability cannot be excluded by law.

11. Governing Law and Disputes

These Terms and Conditions shall be governed by and construed in accordance with the laws of New South Wales, Australia. Any disputes arising out of or in connection with these Terms and Conditions shall be subject to the exclusive jurisdiction of the courts of New South Wales, Australia.
